CARSON CITY FRONTIER DAYS CRAFT SHOW RULES & REGULATIONS

1. **Craft Show hours are Friday, June 4, 2010 from Noon to 8 p.m. and Saturday, June 5, 2010 from 9 a.m. to 8 p.m. If a participant wishes to tear down early, please notify a member of festival staff before doing so in order for possible arrangements to be made. No vehicles will be allowed on show sites during show hours.**
 2. **Craft Show participants will be allowed to drive their vehicles up to their booths during scheduled set-up time and scheduled breakdown time ONLY. At all other times, vehicles must remain in designated parking areas. This is to ensure the safety of customers and spectators, as there will be excessive foot traffic.**
 3. **Craft Show set-up time will be assigned on both Thursday, June 3, beginning at 6 p.m. and Friday, June 4, beginning at 7 a.m. Directions for set-up will be sent with confirmations. Site assignments will be given upon arrival at your set-up time.**
 4. **Booth size is 12' x 12'. Tents and canopies are allowed, but stakes may NOT be driven into the asphalt. However, weighted anchors are highly recommended. Some examples of weighted anchors are cinder blocks, 5-gallon buckets filled with water or cement or milk jugs filled with water. All sites are located on side streets. Craft Show is outside.**
 5. **The use of a generator at the Craft Show is prohibited. There will NOT be access to electricity. Participants must provide their own tables and chairs.**
 6. **Carson City Frontier Days, Inc. expects participants to carry liability insurance for their own protection.**
 7. **Participants will receive confirmation of set-up time and directions within one week of the show.**
 8. **Local law enforcement and festival staff will be available throughout the day and evening on Friday and Saturday. However, displays left out overnight are done so at the participants risk.**
 9. **Trash receptacles will be located throughout the show site for the convenience of the participants and may not be brought into individual booths.**
 10. **The sale of real weapons, drug paraphernalia, or alcohol abuse related items is prohibited.**
- * Please note: Failure to comply with these rules and regulations may result in the termination of show participation.**
