

Carson City Frontier Days Craft Show

Saturday, June 6, 2020

9 a.m. – 6 p.m.



Show Specifics:

This is an outdoor show on city streets and in a paved parking lot. There are no spaces on grass.

Space Specifics:

Booths are 12'x12' in size. Tents and canopies are allowed. Stakes **MAY NOT** be driven into the asphalt. It is recommended that weighted anchors be used to prevent your tent or canopy from "escaping" the show. Examples of weighted anchors are cinder blocks, 5-gallon buckets filled with water or cement, or milk jugs filled with water or cement.

Fee: There is a \$20 fee for each 12' x 12' space needed.

Set-Up: Set-up will only occur on the day of the show, which is Saturday, June 6, 2020. Set-up will begin at 7 a.m. on the day of the show. You will be allowed **10 minutes** to drive to your assigned spot and unload your items. You will not be allowed to leave your car in the road or the parking lot any longer than the allotted 10 minutes in order to provide a consistent and fair time frame for everyone. Directions for set-up will be sent with your confirmation email.

Site Assignments: Site assignments will be given upon arrival at the show.

Insurance: Carson City Frontier Days, Inc. expects participants to carry liability insurance for their own protection.

Generator Use: Because the location of the sites does not allow access to electricity, the use of generators is allowed. Please provide a sound barrier and an exhaust filter should you need the use of a generator.

Other Equipment: Participants must provide their own tables and chairs and their own tent or canopy. Participants must also provide their own generator, should they choose to use one.

Garbage Containers: Receptacles for garbage will be located throughout the show site for the convenience of the participants and may NOT be brought into individual booths. These receptacles will be monitored and emptied by festival staff.

Restrictions: The sale of real weapons, drug paraphernalia, or alcohol abuse related items is prohibited.

Confirmations: Participants will receive confirmation of show participation and set-up directions within one week of the show. You must provide an email address on your application, as confirmations will not be sent via mail.
